

# Construction Industry Induction Training CPCCOHS1001A

# **Course Outline**

This course is to be used throughout Australia to meet the requirements of general WHS induction training program specified by the National Code of Practice for Induction Training for Construction Work (ASCC2006). The Unit is designed to meet WHS regulatory authority requirements for WHS induction and must be achieved before access to any building and construction worksite.

This course is for any person wishing to enter the construction industry. Under NT WorkSafe requirements, all persons participating in onsite activities in the building and construction industry must undertake Construction Induction Card training. The course is offered to individuals seeking employment or who are currently employed within the industry but require the nationally accredited unit of competency CPCCOHS1001A Work safely in the construction industry. Re-training may be required by employers where circumstances indicate the need, e.g. upon re-entry, after an absence of two consecutive years. · Understanding the legislative framework & duty of care

- Knowing the responsibilities of employers, employees & contractors
- OHS communication and reporting processes
- Recognising construction site hazards and control methods (risk management)
- Using safety signage and personal protective equipment
- Safe use of plant and equipment
- Being aware of psycho-social workplace factors
- Dealing with accidents and incidents
- Site emergency and evacuation
- Site and public safety

# **Course Delivery & Duration**

Classes commence at 8:30am and finish at 4:00pm. All students are required to be present 15 minutes before course commencement time. Late arrivals may be refused from the course as a failure to attend.

Replacements are allowed provided they have Eagle Training Services NT approval before the start of training and course prerequisites are met.
